CONTRACT SUMMARY

Approve and authorize County judge to sign Amendment 1 of FY2023 Stonegarden Grant. Funds reallocation for El Paso County Sheriff' Office and Constables. Funds to be reallocated within their own Grant Budget. EPCSO to reallocate \$2,000.00 from Overtime and Fringe to Maintenance.

Constable 1, Constable 4 and Constable 6 to reallocate funds from each agencies M&A to fuel to total \$6,000.00. No increase in funding from Grant. Contract 2024-0618

ADDITIONAL BACKGROUND:

- EPSO is requesting a reallocation of funds within the El Paso County Sheriff's Office (EPSO) Stonegarden budget in the amount of \$6,000.00. The funds will be used for a radio consolette previously purchased with OPSG to reprogram and update frequencies for improved radio interoperability for Border Patrol and the El Paso County Sheriff's Office. Some friendly forces will also benefit from the update for communications in the El Paso area.
- Constable 1, Constable 4, and Constable 6 are requesting a reallocation of funds in the amount of \$2,000.00 from each agencies M&A for a total of \$6,000.00 to be moved to Constable 6 fuel. The funds will be used for fuel for a newly acquired bus that will be used for transport during Stonegarden Operations.
