ITD dedicates resources focused on understanding and maintaining organizational and technological solutions to achieve this goal. ITD strives to consolidate our IT solutions to leverage institutional knowledge, focused training, and more efficient support.</p> <p>The Sheriff's Office Criminal Investigations Division utilizes LeadsOnline Real Time Crime Investigations System Subscription to enhance its investigative efforts. This software integrates with WebRMS, enabling Detectives to access pertinent information easily. Detectives can search for stolen property, investigate suspects from other agencies, map crime activities, and automatically retrieve relevant case details from existing records management systems. Real Time Crime Investigations System Subscription supports and assists law enforcement officials in their duties by collecting, maintaining, and disseminating critical data.</p> <p>Similarly, the Sheriff's Office Criminal Investigations Division employs LeadsOnline CellHawk Agency Subscription to analyze communications and device movements, as well as to identify</p>

locations tied to criminal activities, including cell site lists. This product leverages proprietary technologies for cell phone mapping and analytics, accommodating various cell phone service providers. CellHawk Agency Subscription offers extensive analytics for mapping cell phone calls, significantly aiding Sheriff's Office investigations.

The Information Technology Department (ITD) is requesting that the Court approve and authorize County Judge to sign this agreement for the continued use, maintenance, and support of both software. This agreement is for sixty (60) months. This agreement has been reviewed and approved by ITD, the County Attorney's Office, and the Purchasing Department. ITD recommends approval.
