Subject: Approve and authorize the Single Source purchase Thomson Reuters Print and Proview (West Complete) for the El Paso County Attorney's Office from Thomson Reuters / West Publishing Corporation of St. Paul, MN. in the amount of \$78,874.32 for (3) three years. Funds are available in GF-CNTYATTY-BOOKS&SUBSCRIPT. Pursuant to Texas Local Government Code Section 262.024 (c), as a single source item, it is exempt from the provisions of the County Purchasing Act.

Background: El Paso is seeking to purchase a print and proview subscription from Thomson Reuters / West Publishing which provides online specialized content and legal publications.

This agreement continues the subscription to the online specialized content licensed by Thomson Reuters to meet the legal research needs of the El Paso County Attorney's Office, Titles and content differ from our other digital subscriptions. This is an onsite access subscription.

Pursuant to Texas Local Government Code Section 262.024 (c), as a single source item, it is exempt from the provisions of the County Purchasing Act. Single Source will be re-evaluated as required to ensure compliance with statute.
