<b>Background:</b>	The Third Amendment to the Interlocal Agreement between El Paso County and the Camino Real Regional Mobility Authority (CRRMA) expands the scope of the original agreement to include funding and authorization for the construction of passenger bus shelters. The amendment updates project descriptions, invoicing procedures, and responsibilities to ensure compliance with federal and state requirements for grant-funded projects. It clarifies the duties of both parties, including the RMAs role in project management, adherence to procurement standards, and financial oversight, as well as the County's responsibilities for funding and timely payments. The total project budget for this Amendment is \$2,044,420, and the Director of Transit Operations is designated as the County's representative for project coordination.
