Approve and authorize the County Judge to sign the Fixed Price Construction Contract between El Paso County, Texas and El Paso J.A.G. Inc., of El Paso, TX. (the "Contractor") for the Purchase and Installation of a Diesel Generator for the El Paso County Courthouse. Funds are available in CIP24-FAC-CH-CAPOUT-EQUIP. Contract 2024-0580.

ADDITIONAL BACKGROUND:

The current diesel generator is original to the building and is over 30 years old. The life expectancy of a diesel generator is 25-30 years, while the current generator is operational it has surpassed its equipment life and finding replacement parts is challenging and costly. Replacing the generator now before failure is the most proactive approach to ensure that life safety equipment and components are operational during any power failure incident in the near future.
