Subject: GRANT APPLICATION - Approve and authorize the County Attorney to apply for the FY26 Office of the Governor, Victim Resource Program in the amount of \$42,964.51 from October 1, 2025, through September 30, 2026. A match is required by the granting agency in the amount of \$18,893.80 and additional funding in the amount of \$32,610.39 is needed to supplement the program under the grant for a total of \$51,504.49. Funding is available in GF-GADM-XFER OUT-GRANT MATCH. Further, approve and authorize the County Judge to sign the accompanying resolution that is required by the grant. (Contract No. 2025-0086)

Background: This grant will allow the County Attorney's Office to provide direct service to victims of intimate partner violence, sexual assault and/or stalking, who are in the process of progressing from crisis to self-sufficiency and empowerment. The purpose of the Victim Specialist position is to assist victims of intimate partner violence navigate the post-crisis phase of their journey.
