**Subject:** GRANT APPLICATION - Approve and authorize the District Attorney's Office to apply for the FY26 Office of the Governor, El Paso Coordinated Response-Victim Assistance Coordinator in the amount of \$123,391.50 from October 1, 2025, through September 30, 2026. A match in the amount of \$41,130.50 is required. Funding is available in GF-GADM-XFER OUT-GRANT MATCH. Further, approve and authorize the County Judge to sign the required accompanying Resolution. (Contract No. 2025-0142)

**Background:** The 34th Judicial District Attorney's Office is required by law to provide services to victims of crime in all criminal matters within its jurisdiction. This mandate extends to approximately 16,981 victims of crime each year. On August 3, 2019, tragedy struck the city of El Paso. A shooter killed 23 people and injured 25 at the Walmart at Cielo Vista. The shooter has been indicted and is currently being held in jail.
