**Subject:** GRANT APPLICATION - Approve and authorize the County Judge to sign the Office of the Governor FY26 Violence Against Women Justice and Training Program grant application, on behalf of the 65th District Protective Order Court, in the amount of \$104,899.46. A County match in the amount of \$44,899.46 is required by the funding agency and additional funding in the amount of \$132,061.14 is needed to supplement the program under the grant for a total of \$176,960.60. Funding is available in GF-PROTORDERCRT-XFEROUT-GRNT. Further, authorize the County Judge to sign the accompanying resolution. (Contract No. 2025-0146)

**Background:** This grant is on the five-year sustainability plan; that decreases 10% each year of funding for five years. This grant application is the final funding request the program will be eligible to submit. The amount required for match by the funding agency is \$44,899.46; an additional amount of \$132,061.14 for a total match amount \$176,960.60 needed to sustain the program and fund the two full-time positions.
