Background:	<p>On January 2021, the Commissioners Court approved the Interlocal Agreement between El Paso County and El Paso County Community Supervision and Corrections Department for Human Resources Services and Employee Benefits, pursuant to Texas Government Code, Chapter 791, which authorizes local governments of the State to enter into contracts for governmental functions and services to increase their efficiency and effectiveness. The Term of the Agreement is for 3-years with the option to renew for two additional 1-year time periods.</p> <p>This agreement represents the second of the two options to renew which will extend the term effective January 1, 2025 and ending December 31, 2025.</p> <p>All other terms of the Agreement remain the same.</p> <p>The County Attorney Office has reviewed the Second Option to Renew Interlocal Agreement between the County of El Paso and the El Paso County Community Supervision and Corrections Department for Human Resources Services and Employee Benefits.</p>
