Background:	<p>Pursuant to Texas Health & Safety Code §774.003(a), the Commissioners Court desires to exercise its authorize to provide for emergency ambulance service in the county, including provision of necessary equipment, personnel and maintenance for the service; and pursuant to Texas Local Government Code §262.024(a)(2), Commissioners Court finds that Life Ambulance Service's provision of life ambulance services in the County is necessary to preserve and protect the public health and safety of its residents.</p> <p>The County seeks to enter into an agreement with Life Ambulance, Inc. to provide emergency services throughout the County, excluding the cities of El Paso, Socorro, and Horizon. The proposed agreement will have a two-year term with the option to extend for three additional one-year periods. The total contract amount is \$407,052 per year, amounting to \$814,104 for the two-year term.</p> <p>The contract has been reviewed by the County Attorney's Office.</p>
