A match in the amount of \$40,316.00 is required. Funding is available in GF-GADM-XFER OUT-GRANT MATCH. Further, approve and authorize the County Judge to sign the required accompanying Resolution. **Background:** This grant will enhance the County Attorney's Office ability to provide services to victims of intimate partner violence, sexual assault and/or stalking, who are in the process of progressing from crisis to self-sufficiency and empowerment. The Victim Advocate position will provide the following services: monitor and assist victims to follow through with supportive service providers; respond to the emotional and physical needs of crime victims; provide crisis intervention and assistance
