ADDITIONAL BACKGROUND:

The Criminal Justice Coordination Department received a grant in the amount of \$800,000 from the Department of Justice, Bureau of Justice Assistance for the FY23 Swift, Certain, and Fair Supervision Program. This subrecipient agreement with the University of Texas El Paso will allow for research and evaluation of the program to determine the efficacy of the Principles of Project HOPE on DWI 2nd pretrial supervision cases.
