Funds are available in SG-ARPLAN21-OPERATING EX. Pursuant to Texas Local Government Code Section 262.024 (a)(7)(A), as a single source item, it is exempt from the provisions of the County Purchasing Act. Single Source will be re-evaluated at the time of new contract to ensure compliance with statute.
<b>Background:</b>	As part of the County's Strategic Plan, El Paso County Administration is seeking services to conduct a comprehensive evaluation of the Sheriff's Office Crisis Intervention co-response Team (CIT). Meadows Mental Health Policy Institute (Meadows Institute) brings experience, design, implementation, and evaluation of similar projects, including an evaluation of the City of El Paso's C.I.T. Program. They will conduct an efficacy analysis of the program including an analysis of the impacts of the pandemic on crisis response. Pursuant to Texas Local Government Code Section 262.024 (a)(7)(A), as a sole source item, it is exempt from the provisions of the County Purchasing Act.
