**Subject:** Approve and authorize the County Judge to sign the Subrecipient Agreement with the Ysleta Independent School District for the El Paso County Sheriff's Office to provide English as a Second Language classes to a certain population at the County Jail from October 27, 2024, to September 30, 2025, in the amount of \$23,172. Funding is available in SG-REENTRY21-OPERATING EX. (Contract No. 2024-0873)

**Background:** The Criminal Justice Coordination Department works closely with the El Paso County Sheriff's Department to provide reentry services in the El Paso County Jail Annex. One provision of these services is the Project Chance Program which provides comprehensive classes to detainees in three pods via a 90-day intensive program. This program was originally funded through a BJA grant.

An agreement was signed in 2022 with the Sheriff's Office, Reentry Support Services (then under Community Services), and the Ysleta Independent School District to provide educational services in the jail annex.

In 2024, the Sheriff's Office approached the CJC to determine if there was any funding available to continue the English as a Second Language courses. The CJC determined it had additional funding in the amount of \$23,172 from the original BJA grant that could be utilized. Subsequently, the BJA has approved the reallocation of funding for this purpose.
