WHEREAS, the Agreement expired on or about September 30, 2024; and


WHEREAS, the County and Vendor agree to amend the Agreement as follows:

WHEREAS, the Agreement expired on or about September 30, 2024; and


WHEREAS, the County and Vendor agree to amend the Agreement as follows:
