Introduction

The purpose of this funding is to support development and implementation of residential substance abuse treatment programs within correctional and detention facilities in which prisoners are incarcerated for a period of time sufficient to permit substance abuse treatment and after-care programs for those prisoners.

Program-Specific Questions

Drug Testing

Projects must perform urinalysis or conduct other proven reliable methods of drug and alcohol testing for program participants and former participants while they remain in the custody of the state or local government.

Describe the testing policy, including the method used for testing and the frequency of testing for participants:

The drug testing procedures for participants in the Residential Substance Abuse Treatment (RSAT) program utilize various methods and are conducted at different stages throughout the program. Participants are tested upon intake, at program exit, and randomly throughout their treatment. Additionally, participants are tested upon returning from any appointments outside the facility. RSAT monitoring staff administer instant drug urinalysis screenings (UA) and Breath Analysis (BA) tests onsite. If a sample tests positive, contested results may be sent to an independent laboratory for confirmation through GC/MS (Gas Chromatography-Mass Spectrometry).

Certifications

In addition to the requirements found in existing statute, regulation, and the funding announcement, this program requires applicant organizations to certify compliance with the following:

Constitutional Compliance

Project Abstract :

In fiscal year 2024, the El Paso County Community Supervision and Corrections Department (El Paso County CSCD) directly supervised 5,382 offenders across 9,213 cases. As of August 31, 2024, 1,890 individuals on probation had alcohol-related offenses, and 1,119 had drug-related offenses, making up 49% of the total offenders under supervision. Additionally, 820 offenders are on probation for manufacturing/delivery charges. Despite the significant need, there is a lack of adequate supervision and treatment resources for the estimated 3,009 chemically dependent offenders supervised by this department. This gap in services contributes to continued criminal behavior, high unemployment, and poverty. The Residential Substance Abuse Treatment (RSAT) program addresses this critical need by providing intensive substance abuse treatment for offenders. Without immediate access to services, many individuals continue to struggle with addiction and criminal behavior. The RSAT program is designed to offer a residential treatment component lasting approximately six months, followed by an aftercare component that lasts between three to six months. Upon court-ordered admission, participants undergo a comprehensive clinical assessment within the first 10 days, utilizing the Texas Health and Human Services Clinical Management for Behavioral Health Services (CMBHS). A treatment plan tailored to each individual is then developed based on the assessment findings. The treatment team includes a Licensed Chemical Dependency Counselor (LCDC), a Clinical Supervisor (Licensed Professional Counselor - LPC), Residential Director, caseworker, and probation officer to provide enhanced residential and aftercare services. The RSAT program incorporates evidence-based treatment models in line with Texas Department of Criminal Justice-Community Justice Assistance Division (TDCJ-CJAD) Best Practices standards. These include Cognitive Behavioral Therapy (CBT), which addresses criminogenic risks and needs, restructures maladaptive thinking, and builds interpersonal skills. The program also integrates psycho-social and life skills programs to support offenders' overall rehabilitation. The RSAT program provides a comprehensive range of psycho-educational classes and counseling services, including substance abuse treatment, stress/anger management, cognitive and life skills development, and educational assistance. Each participant's treatment plan is individualized and updated at the end of each phase to ensure progress is being made. All residents are required to participate in 40 hours of structured activities per week, tailored to their specific needs. The primary goal of the RSAT program is to reduce recidivism and prevent continued substance abuse. By equipping participants with the tools necessary to cope with triggers and stressors, the program aims to decrease the likelihood of reoffending or relapse. Additionally, the program emphasizes coordination with community correctional staff, substance abuse, mental health, and social service agencies to create a comprehensive aftercare treatment plan and support network upon reintegration into the community. Success is tracked for up to one year following program exit to assess long-term outcomes.

Problem Statement :

El Paso County spans over 1,015 square miles and is home to more than 889,880 residents as of July 2023, according to the U.S. Census Bureau. Bordered by Doña Ana County, New Mexico, and Ciudad Juárez, Chihuahua, Mexico, the region's proximity to an international border contributes to heightened vulnerability to crime, including drug and human trafficking, as well as substance abuse. The U.S. government has designated this area as a High-Intensity Drug Trafficking Area (HIDTA). Economic challenges further exacerbate these issues. With a median household income of \$58,859 and 18.5% of the population living in poverty, El Paso County is classified as economically depressed. The majority of individuals processed through the county's court system are indigent. Substance abuse-related offenses account for 49% of all adult cases supervised by the El Paso County Community Supervision and Corrections Department (CSCD) in FY 2024. Despite the critical need for substance abuse treatment, the availability of services is severely limited. Many justice-involved individuals face long waiting lists or lack access to treatment altogether. The shortage of resources also hampers adequate screening and assessment for chemical dependency, leading to delays in proper treatment placement. The Residential Substance Abuse Treatment (RSAT) program addresses this gap by providing intensive residential treatment for eligible male and female offenders aged 18 and older. Each participant undergoes clinical screening and assessment through the Texas Department of State Health Services Clinical Management for Behavioral Health Services (CMBHS) system. This process ensures the development of an individualized treatment plan tailored to the participant's specific needs and level of care. Research indicates that offenders who receive substance abuse treatment are significantly less likely to reoffend, with 30%-50% achieving long-term abstinence from drugs. However, limited resources in El Paso County jeopardize the availability and efficacy of such programs. Expanding RSAT will ensure timely access to treatment, comprehensive assessments, and tailored services to address substance abuse and reduce recidivism rates in the region.

Supporting Data :

Substance abuse, illicit drug use and sales, and crimes committed under the influence of drugs or alcohol are critical risk factors impacting our community. These issues are exacerbated by the growing violence in Ciudad Juárez, Mexico, El Paso's sister city across the U.S.-Mexico border. Ciudad Juárez, with a population of 1.6 million, is one of the deadliest cities in the world. According to BorderReport, the city recorded over 300 homicides in the first quarter of 2024, averaging approximately 3.3 murders per day. Drug-related violence across the border increasingly affects El Paso, intensifying the need for substance abuse interventions and support services. El Paso County CSCD supervised 5,586 offenders in FY 2024, of which: • 1,119 cases involved drug-related offenses. • 1,890 cases involved alcohol-related

offenses. • Combined: 3,009 cases (49% of all supervised adults) were chemically dependent. Statewide, the Texas Department of Criminal Justice-Community Justice Assistance Division (TDCJ-CJAD) reported 225,287 felony offenders on community supervision as of August 31, 2024. These figures underscore the urgent need for comprehensive substance abuse assessment and treatment services. The Health and Human Services Commission (HHSC) Substance Use Disorder (SUD) Assessment is a vital tool used by El Paso County CSCD to evaluate offenders' needs and develop tailored treatment plans. This updated assessment system includes: • Severity score calculations identifying Mild, Moderate, or Severe DSM-5 diagnoses. • Treatment recommendations based on American Society of Addiction Medicine (ASAM) criteria. • ASAM treatment modifications displayed within the assessment's recommendations. The SUD Assessment is designed to guide counselors in conducting interviews that build rapport with clients while collecting accurate information. This process ensures appropriate treatment recommendations and supports the development of effective, individualized treatment plans. Additionally, the Addiction Severity Index (ASI) enhances the assessment process by evaluating clients across seven key life areas: 1. Medical status 2. Employment and support 3. Drug and alcohol use 4. Legal issues 5. Family history 6. Social relationships 7. Psychiatric concerns and trauma The ASI's versatility allows it to be used with diverse populations, regardless of gender, socioeconomic status, or literacy level. El Paso County CSCD is the only Adult Probation Department in Texas authorized to use the Clinical Management for Behavioral Health Services (CMBHS) system. In FY 2024, the department used CMBHS to assess 1,717 offenders with substance abuse or mental health needs. Licensed Chemical Dependency Counselors (LCDCs) provided: • 16,386 hours of group counseling. • 5,586 hours of individual counseling. Despite these efforts, the overwhelming demand for treatment services often exceeds availability, resulting in waiting lists or lack of access to necessary care. Expanding resources is critical to addressing the needs of justice-involved individuals and reducing recidivism. Additionally, the County of El Paso is mandated to establish a drug court under the Texas Government Code 123.006, §469.006. * El Paso County CSCD Officer Caseload by Date Report (September 1, 2023 to August 31, 2024), report. **TCCJ-CJAD TAIP Quarterly Reports FY 2024. Project Approach & Activities:

Within ten (10) days of placement into the RSAT program, participants undergo a clinical screening and assessment using the Clinical Management for Behavioral Health Services (CMBHS) system. This ensures the appropriate intensity of treatment services. Based on the assessment results, an Individualized Treatment Plan (ITP) is developed, tailored to the participant's specific needs and the determined Level of Care. The RSAT program is staffed by a dedicated team that includes: • One (1) Assistant Residential Director: Responsible for coordinating mental health services, developing, implementing, and evaluating programs within the residential treatment facility. The Assistant Director ensures all programs align with evidence-based practices for substance abuse treatment. • One (1) Clinical Director and Licensed Professional Counselor (LPC): Directs the clinical service delivery system using psychotherapeutic and human development principles. Duties include providing clinical oversight to the counseling team, reviewing and approving admissions and discharges, conducting assessments to evaluate clients' risk and needs, and developing treatment plans. • Two (2) Licensed Chemical Dependency Counselors (LCDCs): One male and one female, responsible for assessing Level of Care and providing individual and group counseling. They utilize evidence-based models such as Seeking Safety and Moral Reconation Therapy (MRT). • One (1) Caseworker: Provides case management services in alignment with treatment plan goals. The caseworker facilitates psycho-educational wellness groups that focus on skill-building areas such as conflict resolution, stress management, health and wellness, and drug/alcohol education. Individualized service needs and measurable objectives are detailed in a treatment plan, which guides the participant's therapeutic journey throughout their stay. These plans are updated at the conclusion of each treatment phase. All participants are required to engage in 30 hours of structured activities per week tailored to their specific needs. The RSAT program is designed to last up to six (6) months. However, in compliance with TDCJ-CJAD Substance Abuse Treatment Standards, the Continuum of Care for Substance Abuse Treatment Model, and Best Practices in Treatment Planning, the length of stay is determined by the participant's progress toward treatment plan goals. • Phase I – Orientation: Participants are introduced to the treatment environment, and an individualized treatment plan is developed. • Phases II & III – Skill Development: These phases focus on developing cognitive and life skills essential for long-term sobriety, including stress/anger management, substance abuse education, and vocational or educational support as identified during assessments. Aftercare Component Upon successful completion of the residential phase, participants transition to the Aftercare Component, managed by El Paso County CSCD's Aftercare Caseload. This phase lasts three (3) to six (6) months, providing continued support to maintain treatment progress.

Capacity & Capabilities:

Performance Management :

The goal of the El Paso County CSCD's Residential Substance Abuse Treatment program is to provide comprehensive residential and aftercare substance abuse treatment services to High-Risk /High Need male and female offenders to reduce risk of recidivism and foster long-term recovery and support. Another goal of the RSAT Program is to support and enhance treatment services for chemically dependent offenders in El Paso County. The program utilizes four electronic record keeping systems to ensure accurate tracking and documentation. The Caseworkers and the Community Supervision Officer will enter UA/BA results and document any participant contact with the participants and court visits into Odyssey. They will also collect all TRAS information for CJD reporting purposes in the TDCJ portal. The treatment staff will utilize the CMBHS for clinical information. Our fiscal auditor operates with the use of MUNIS for financial electronic record keeping.

Target Group :

Our target population consists of adult males and females (18 years and older) with a substance abuse disorder. We have the capacity to accommodate 20 male beds and 20 female beds at any given time. The individuals served by our program are high-risk, high-need offenders who have not been successful in a lower level of care.

Evidence-Based Practices:

The evidence-based principles component of the integrated model highlights eight principles for effective offender interventions. The organization or system that is most successful in initiating and maintaining offender interventions and supervision practices consistent with these principles will likely realize the greatest recidivism reductions. The following framework of principles is listed in developmental order and they are all highly interdependent. For example, offender assessments must consider both risk to reoffend and criminogenic needs, in that order. Research indicates that resources are used more effectively when they are focused on higher-risk rather than lower-risk offenders, therefore considering offenders' risk to reoffend prior to addressing criminogenic needs allows agencies to target resources on higher-risk offenders. Eight Evidence-Based Principles for Effective Interventions: 1. Assess Actuarial Risk/Needs (Clinical Management

The purpose of this funding is to support development and implementation of residential substance abuse treatment programs within correctional and detention facilities in which prisoners are incarcerated for a period of time sufficient to permit substance abuse treatment and after-care programs for those prisoners.

The drug testing procedures for participants in the Residential Substance Abuse Treatment (RSAT) program utilize various methods and are conducted at different stages throughout the program. Participants are tested upon intake, at program exit, and randomly throughout their treatment. Additionally, participants are tested upon returning from any appointments outside the facility. RSAT monitoring staff administer instant drug urinalysis screenings (UA) and Breath Analysis (BA) tests onsite. If a sample tests positive, contested results may be sent to an independent laboratory for confirmation through GC/MS (Gas Chromatography-Mass Spectrometry).

Certifications

In addition to the requirements found in existing statute, regulation, and the funding announcement, this program requires applicant organizations to certify compliance with the following:

Project Abstract :

In fiscal year 2024, the El Paso County Community Supervision and Corrections Department (El Paso County CSCD) directly supervised 5,382 offenders across 9,213 cases. As of August 31, 2024, 1,890 individuals on probation had alcohol-related offenses, and 1,119 had drug-related offenses, making up 49% of the total offenders under supervision. Additionally, 820 offenders are on probation for manufacturing/delivery charges. Despite the significant need, there is a lack of adequate supervision and treatment resources for the estimated 3,009 chemically dependent offenders supervised by this department. This gap in services contributes to continued criminal behavior, high unemployment, and poverty. The Residential Substance Abuse Treatment (RSAT) program addresses this critical need by providing intensive substance abuse treatment for offenders. Without immediate access to services, many individuals continue to struggle with addiction and criminal behavior. The RSAT program is designed to offer a residential treatment component lasting approximately six months, followed by an aftercare component that lasts between three to six months. Upon court-ordered admission, participants undergo a comprehensive clinical assessment within the first 10 days, utilizing the Texas Health and Human Services Clinical Management for Behavioral Health Services (CMBHS). A treatment plan tailored to each individual is then developed based on the assessment findings. The treatment team includes a Licensed Chemical Dependency Counselor (LCDC), a Clinical Supervisor (Licensed Professional Counselor - LPC), Residential Director, caseworker, and probation officer to provide enhanced residential and aftercare services. The RSAT program incorporates evidence-based treatment models in line with Texas Department of Criminal Justice-Community Justice Assistance Division (TDCJ-CJAD) Best Practices standards. These include Cognitive Behavioral Therapy (CBT), which addresses criminogenic risks and needs, restructures maladaptive thinking, and builds interpersonal skills. The program also integrates psycho-social and life skills programs to support offenders' overall rehabilitation. The RSAT program provides a comprehensive range of psycho-educational classes and counseling services, including substance abuse treatment, stress/anger management, cognitive and life skills development, and educational assistance. Each participant's treatment plan is individualized and updated at the end of each phase to ensure progress is being made. All residents are required to participate in 40 hours of structured activities per week, tailored to their specific needs. The primary goal of the RSAT program is to reduce recidivism and prevent continued substance abuse. By equipping participants with the tools necessary to cope with triggers and stressors, the program aims to decrease the likelihood of reoffending or relapse. Additionally, the program emphasizes coordination with community correctional staff, substance abuse, mental health, and social service agencies to create a comprehensive aftercare treatment plan and support network upon reintegration into the community. Success is tracked for up to one year following program exit to assess long-term outcomes.

Problem Statement :

El Paso County spans over 1,015 square miles and is home to more than 889,880 residents as of July 2023, according to the U.S. Census Bureau. Bordered by Doña Ana County, New Mexico, and Ciudad Juárez, Chihuahua, Mexico, the region's proximity to an international border contributes to heightened vulnerability to crime, including drug and human trafficking, as well as substance abuse. The U.S. government has designated this area as a High-Intensity Drug Trafficking Area (HIDTA). Economic challenges further exacerbate these issues. With a median household income of \$58,859 and 18.5% of the population living in poverty, El Paso County is classified as economically depressed. The majority of individuals processed through the county's court system are indigent. Substance abuse-related offenses account for 49% of all adult cases supervised by the El Paso County Community Supervision and Corrections Department (CSCD) in FY 2024. Despite the critical need for substance abuse treatment, the availability of services is severely limited. Many justice-involved individuals face long waiting lists or lack access to treatment altogether. The shortage of resources also hampers adequate screening and assessment for chemical dependency, leading to delays in proper treatment placement. The Residential Substance Abuse Treatment (RSAT) program addresses this gap by providing intensive residential treatment for eligible male and female offenders aged 18 and older. Each participant undergoes clinical screening and assessment through the Texas Department of State Health Services Clinical Management for Behavioral Health Services (CMBHS) system. This process ensures the development of an individualized treatment plan tailored to the participant's specific needs and level of care. Research indicates that offenders who receive substance abuse treatment are significantly less likely to reoffend, with 30%-50% achieving long-term abstinence from drugs. However, limited resources in El Paso County jeopardize the availability and efficacy of such programs. Expanding RSAT will ensure timely access to treatment, comprehensive assessments, and tailored services to address substance abuse and reduce recidivism rates in the region.

Supporting Data :

Substance abuse, illicit drug use and sales, and crimes committed under the influence of drugs or alcohol are critical risk factors impacting our community. These issues are exacerbated by the growing violence in Ciudad Juárez, Mexico, El Paso's sister city across the U.S.-Mexico border. Ciudad Juárez, with a population of 1.6 million, is one of the deadliest cities in the world. According to BorderReport, the city recorded over 300 homicides in the first quarter of 2024, averaging approximately 3.3 murders per day. Drug-related violence across the border increasingly affects El Paso, intensifying the need for substance abuse interventions and support services. El Paso County CSCD supervised 5,586 offenders in FY 2024, of which: • 1,119 cases involved drug-related offenses. • 1,890 cases involved alcohol-related

offenses. • Combined: 3,009 cases (49% of all supervised adults) were chemically dependent. Statewide, the Texas Department of Criminal Justice-Community Justice Assistance Division (TDCJ-CJAD) reported 225,287 felony offenders on community supervision as of August 31, 2024. These figures underscore the urgent need for comprehensive substance abuse assessment and treatment services. The Health and Human Services Commission (HHSC) Substance Use Disorder (SUD) Assessment is a vital tool used by El Paso County CSCD to evaluate offenders' needs and develop tailored treatment plans. This updated assessment system includes: • Severity score calculations identifying Mild, Moderate, or Severe DSM-5 diagnoses. • Treatment recommendations based on American Society of Addiction Medicine (ASAM) criteria. • ASAM treatment modifications displayed within the assessment's recommendations. The SUD Assessment is designed to guide counselors in conducting interviews that build rapport with clients while collecting accurate information. This process ensures appropriate treatment recommendations and supports the development of effective, individualized treatment plans. Additionally, the Addiction Severity Index (ASI) enhances the assessment process by evaluating clients across seven key life areas: 1. Medical status 2. Employment and support 3. Drug and alcohol use 4. Legal issues 5. Family history 6. Social relationships 7. Psychiatric concerns and trauma The ASI's versatility allows it to be used with diverse populations, regardless of gender, socioeconomic status, or literacy level. El Paso County CSCD is the only Adult Probation Department in Texas authorized to use the Clinical Management for Behavioral Health Services (CMBHS) system. In FY 2024, the department used CMBHS to assess 1,717 offenders with substance abuse or mental health needs. Licensed Chemical Dependency Counselors (LCDCs) provided: • 16,386 hours of group counseling. • 5,586 hours of individual counseling. Despite these efforts, the overwhelming demand for treatment services often exceeds availability, resulting in waiting lists or lack of access to necessary care. Expanding resources is critical to addressing the needs of justice-involved individuals and reducing recidivism. Additionally, the County of El Paso is mandated to establish a drug court under the Texas Government Code 123.006, §469.006. * El Paso County CSCD Officer Caseload by Date Report (September 1, 2023 to August 31, 2024), report. **TCCJ-CJAD TAIP Quarterly Reports FY 2024. Project Approach & Activities:

Within ten (10) days of placement into the RSAT program, participants undergo a clinical screening and assessment using the Clinical Management for Behavioral Health Services (CMBHS) system. This ensures the appropriate intensity of treatment services. Based on the assessment results, an Individualized Treatment Plan (ITP) is developed, tailored to the participant's specific needs and the determined Level of Care. The RSAT program is staffed by a dedicated team that includes: • One (1) Assistant Residential Director: Responsible for coordinating mental health services, developing, implementing, and evaluating programs within the residential treatment facility. The Assistant Director ensures all programs align with evidence-based practices for substance abuse treatment. • One (1) Clinical Director and Licensed Professional Counselor (LPC): Directs the clinical service delivery system using psychotherapeutic and human development principles. Duties include providing clinical oversight to the counseling team, reviewing and approving admissions and discharges, conducting assessments to evaluate clients' risk and needs, and developing treatment plans. • Two (2) Licensed Chemical Dependency Counselors (LCDCs): One male and one female, responsible for assessing Level of Care and providing individual and group counseling. They utilize evidence-based models such as Seeking Safety and Moral Reconation Therapy (MRT). • One (1) Caseworker: Provides case management services in alignment with treatment plan goals. The caseworker facilitates psycho-educational wellness groups that focus on skill-building areas such as conflict resolution, stress management, health and wellness, and drug/alcohol education. Individualized service needs and measurable objectives are detailed in a treatment plan, which guides the participant's therapeutic journey throughout their stay. These plans are updated at the conclusion of each treatment phase. All participants are required to engage in 30 hours of structured activities per week tailored to their specific needs. The RSAT program is designed to last up to six (6) months. However, in compliance with TDCJ-CJAD Substance Abuse Treatment Standards, the Continuum of Care for Substance Abuse Treatment Model, and Best Practices in Treatment Planning, the length of stay is determined by the participant's progress toward treatment plan goals. • Phase I – Orientation: Participants are introduced to the treatment environment, and an individualized treatment plan is developed. • Phases II & III – Skill Development: These phases focus on developing cognitive and life skills essential for long-term sobriety, including stress/anger management, substance abuse education, and vocational or educational support as identified during assessments. Aftercare Component Upon successful completion of the residential phase, participants transition to the Aftercare Component, managed by El Paso County CSCD's Aftercare Caseload. This phase lasts three (3) to six (6) months, providing continued support to maintain treatment progress.

Capacity & Capabilities:

Performance Management :

The goal of the El Paso County CSCD's Residential Substance Abuse Treatment program is to provide comprehensive residential and aftercare substance abuse treatment services to High-Risk /High Need male and female offenders to reduce risk of recidivism and foster long-term recovery and support. Another goal of the RSAT Program is to support and enhance treatment services for chemically dependent offenders in El Paso County. The program utilizes four electronic record keeping systems to ensure accurate tracking and documentation. The Caseworkers and the Community Supervision Officer will enter UA/BA results and document any participant contact with the participants and court visits into Odyssey. They will also collect all TRAS information for CJD reporting purposes in the TDCJ portal. The treatment staff will utilize the CMBHS for clinical information. Our fiscal auditor operates with the use of MUNIS for financial electronic record keeping.

Target Group :

Our target population consists of adult males and females (18 years and older) with a substance abuse disorder. We have the capacity to accommodate 20 male beds and 20 female beds at any given time. The individuals served by our program are high-risk, high-need offenders who have not been successful in a lower level of care.

Evidence-Based Practices:

The evidence-based principles component of the integrated model highlights eight principles for effective offender interventions. The organization or system that is most successful in initiating and maintaining offender interventions and supervision practices consistent with these principles will likely realize the greatest recidivism reductions. The following framework of principles is listed in developmental order and they are all highly interdependent. For example, offender assessments must consider both risk to reoffend and criminogenic needs, in that order. Research indicates that resources are used more effectively when they are focused on higher-risk rather than lower-risk offenders, therefore considering offenders' risk to reoffend prior to addressing criminogenic needs allows agencies to target resources on higher-risk offenders. Eight Evidence-Based Principles for Effective Interventions: 1. Assess Actuarial Risk/Needs (Clinical Management

Behavioral Health Services (CMBHS) and Trauma Informed Care; 2. Enhance Intrinsic Motivation; 3. Target Interventions- Individualized Treatment Plans using Seeking Safety Model; a. Risk Principle: Prioritize supervision and treatment resources for higher risk participants; b. Need Principle: Target to criminogenic needs; c. Responsivity Principle: Be responsive to temperament, learning style, motivation, culture, and gender specific treatment programs; d. Dosage: Structure 40-70% of high-risk offenders' time for 3-9 months; 4. Skill Train with Directed Practice (EBP Seeking Safety - Cognitive Behavioral treatment methods); 5. Increase Positive Reinforcement.(Motivational Interviewing); 6. Engage Ongoing Support in Natural Communities (Service Coordination); 7. Measure Relevant Processes/Practices. (Monitor Supervision and Treatment Plan Compliance); 8. Provide Measurement Feedback. (Evaluation of Risk, Supervision, and Treatment Level) ; Evidence-based practices indicate that interventions should be driven by individual assessment, and that appropriate treatment should be done in the least restrictive setting available to meet the offender's criminogenic needs. The treatment plan is an assessment-driven progressive treatment and sanction model. Participants are screened for mental health problems and services are brokered if deemed necessary. The cognitive based component focuses on changing the offender's way of thinking by helping the offender to overcome difficulties by identifying and changing dysfunctional thinking, behavior, and emotional responses. This process involves helping offenders develop skills for modifying beliefs, identifying distorted thinking, relating to others in different ways, and changing behaviors. The community service required of the offenders is a restorative justice concept that allows the offenders to earn their way back into the community. Research on effective interventions with offenders show that programs with a cognitive/behavioral component have a high probability of reducing recidivism (Latessa1 and Gendreau2). Most recently the program has implemented Moral Reconciliation Therapy (MRT) which is a cognitive behavioral program for substance abuse treatment.
