Background:	<p>The focus of this project is providing necessary equipment to the El Paso County Sheriff's Office (EPCSO) special response teams. Through the Office of the Governor Rifle-Resistant Body Armor Grant Program, the Sheriff's Office proposes to purchase plates that serve as a vital line of defense against ballistic threats. The equipment request is to purchase 54 Level III and Level IV vests that will result in the safeguarding of the officers' life and well-being of the special response teams: Crisis Intervention Team (CIT) team, Special Weapons, Tactics (SWAT) team, and Crisis Negotiation Team (CNT) team. The total request for FY 2025-2026 is \$53,100.00 with no match required. No personnel funds are requested in this grant.</p>
