# 89<sup>th</sup> Legislative Session Updates

- Deadline to file bills: March 14<sup>th</sup>
- House Committees began holding organizational hearings on 3/3
- House Appropriations Subcommittees began hearings on 2/24
  - TxDOT provided updates on railroad grade crossings, the implementation of SB 224 (88R) –a catalytic converter bill passed last session– and ongoing infrastructure projects
  - BDO discussed the Broadband Infrastructure Fund and Federal BEAD grant funding
  - DFPS highlighted their focus on increasing investments in Adult Protective Services this session
  - DSHS emphasized the need for additional funding for vaccine and immunization education

# *State of the Judiciary*

- On February 26, Texas Supreme Court Chief Justice Jimmy Blacklock delivered his inaugural State of the Judiciary address to Texas lawmakers
  - called on lawmakers to prioritize an increase in judicial salaries and reiterated that the base pay for district judges has not been raised since 2013, putting Texas 48th out of 50 states for judicial salaries
  - asked to tighten restrictions on when a defendant can be let out on bail, and said this is necessary to support law enforcement
  - called for changes to reevaluate current practices within the child welfare system– to allow families to stay together more easily, saying using the “coercive power of the state ... to destroy a family should never be our first instinct”

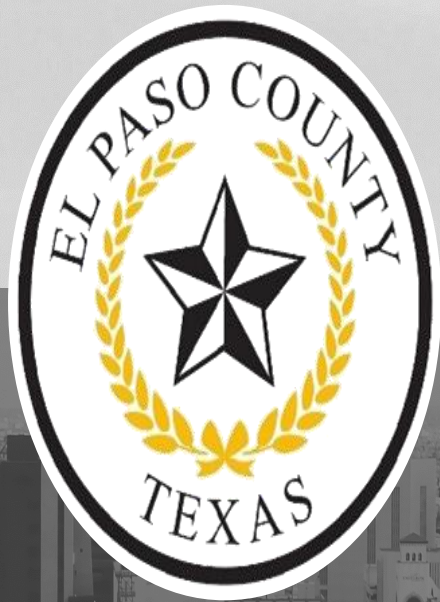
# 119<sup>th</sup> U.S. Congress Updates

- The House of Representatives approved its Congressional Budget Resolution
  - includes spending cuts, raising the national debt, continued funding for the 2017 tax cuts, and increased border security
  - the US Senate's committees must finalize legislation for their smaller budget package by March 7
  - Once both chambers complete their respective proposals, leadership must agree on a process to reconcile the differences between the two versions
- Trump gave the State of the Union address
  - Senator Elissa Slotkin gave the Democratic response

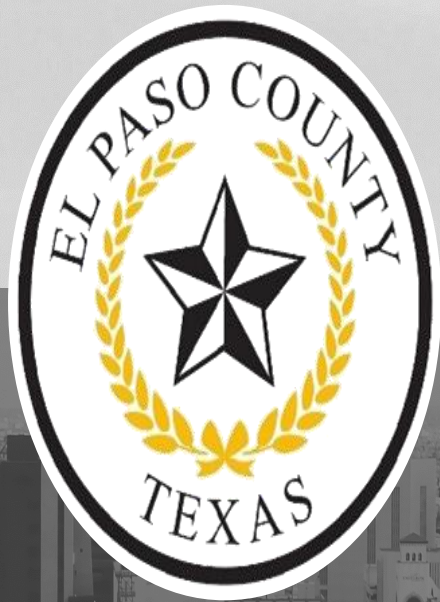
