**Subject:** Approve and authorize the County Judge to sign the updated letter to request temporary housing from the State for Operation Lonestar (OLS) detainees to reflect Sheriff Oscar Ugarte's support of the request. (#7578-OP)

**Background:** Due to a policy decision by the State known as Operation Lonestar (OLS), DPS has surged resources to our region that results in a higher number of arrests for charges like smuggling, drug trafficking, and more. This impacts County jail operations and costs, which has also impacted the ability to provide jail beds to the US Marshals which has reduced County revenues significantly. The County Sheriff is required to house persons arrested with state charges and presented to his office for detention. Over the past year, we have seen over 400 detainees on a daily count under Operation Lonestar and numbers remain above 150 currently. The impact of this is the costs for these detainees are now paid by the County and local taxpayers. Additionally, we no longer have these beds to generate revenue from the US Marshal.

In Fall 2024, the Court authorized the County Judge to sign a letter requesting temporary housing from Texas Commission on Jail Standards (TCJS). TCJS has agreed and we are continuing with the process, but need an updated form due to the change in the Sheriff's Office. The attached letter now reflects Sheriff Oscar Ugarte as the office holder and he has agreed to the request as he understands the impact this has on the County and our community.

We are seeking your approval to have the County Judge sign this updated letter to request temporary housing from the State for OLS detainees.
