Background:	<p>The El Paso County requires the services of a Contractor to assist the County in reviewing federal regulations and then negotiating with the United States Marshal Service (USMS) a new per diem and transportation/guard service rate for IGA 80-99-0067 that governs the County's housing of federal prisoners in the El Paso County Detention Center.</p> <p>Contractor will work with El Paso County staff to collect all allowable and allocable economic data regarding the costs associated with the current and future operation of the El Paso County Detention Center. Contractor will prepare El Paso County's application to USMS, ensuring that it is in compliance with the U.S. Office of Management & Budget Circular 200; Chapter XXVIII – Department of Justice (2 CFR 200) and Section 119 of the Department of Justice Appropriations Act of 2001 (Public Law 106-553).</p>
