RESOLUTION



WHEREAS, 1 in 36 children are affected by autism in the United States, a life-long developmental disability that impacts communication and social interactions. Autism may include repetitive activities and behaviors, resistance to changes in the environment and daily routines, and sensory sensitivities, and while there is no known single cause, it is well documented that if individuals with autism receive an early diagnosis, intervention, and appropriate education, it is often possible for those individuals to transition to greater independence; and,

WHEREAS, Angel's Mission works for integration through inclusion, providing resources and education that empower the families of people with Intellectual and Developmental Disabilities (IDD), autism, and other disabilities; and,

WHEREAS, Autism awareness tells us about autism as a condition, autism acceptance celebrates the strengths, abilities, and contributions those on the autistic spectrum contribute to society. Through understanding, education, and advocacy, together we make our community a stronger one, where those with autism are able to not only live as they are but flourish.
