SECOND AMENDMENT TO CONTRACT INSIGHT ENTERPRISE SOFTWARE LICENSE
AND HOSTING SERVICES AGREEMENT

On the 4th day of April, 2023, the County of El Paso, Texas ("County"), and CobbleStone Systems Corp. d.b.a. CobbleStone Software ("Vendor"), located at 428 South White Horse Pike Lindenwold, New Jersey 08021, entered into a CobbleStone Software License Agreement ("Agreement") (County Contract # 2022-1024), incorporated by reference for all purposes. The Parties now desire to amend the Agreement.

WHEREAS, the Agreement expired on or about April 3, 2025; and

WHEREAS, the County and Vendor agree to renew the Agreement for an additional one year term;

NOW, THEREFORE, the County and Vendor agree to amend the Agreement as follows:

1. In accordance with Section 3. Term, Prices, and Payment of the Agreement, the parties agree to renew the Agreement for a term of one (1) year. The renewal term will be from April 4, 2025 to April 3, 2026.
2. The total price for products and services for the renewal term is \$30,227.83.
3. The description of products and services for the renewal term are further provided in Vendor Renewal Quote dated February 24, 2025, and incorporated by reference for all purposes.
4. Except as specifically stated in this Amendment all other terms and conditions of the Agreement remain the same and in full force and effect.
5. This Amendment together with the Agreement comprise the entire agreement between the parties (hereafter "Agreement").
6. The Agreement is effective as of the date executed by both parties.
