Dear Mr. Hamilton and Ms. Williams,

The purpose of this letter is to provide notice of termination of all of the aforementioned SSP grants on behalf of El Paso County (the "County"). El Paso County wound down its Migrant Support Services Center in December 2024 without use of SSP funding. Therefore, because

El Paso County has not and will not submit any requests for reimbursement through its SSP grant awards, the County hereby provides notice to wholly terminate each of its SSP grants. This notice of termination is intended to take immediate effect.

Finally, because the County has not incurred any expenses to be allocated to, or to be reimbursed by, SSP funding, it does not understand a written response related to carrying out the scope of the SSP award to be required under the March 11, 2025, letter to the County.
