**WHEREAS**, Joshua Marmolejo has been recognized as a recipient of the prestigious 2024-25 Milken Educator Award, an honor bestowed upon outstanding educators across the country, along with a \$25,000 cash prize for his exceptional contributions to education; and,

**WHEREAS**, he is a dedicated and innovative educator at Clint High School, where he leads the P-TECH (Pathways of Technology Early College High School) automotive technology program in partnership with El Paso Community College, creating opportunities for students to obtain high school diplomas, industry-recognized credentials, and even associate degrees; and,

**WHEREAS**, Joshua Marmolejo is the first-ever Milken Educator Award recipient in the history of Clint Independent School District, a testament to his leadership, commitment to student success, and impact on the future of education within the district; and,

**WHEREAS**, his contributions extend beyond the classroom as he serves on Clint High School's P-TECH advisory committee, homecoming planning team, and Professional Learning Community, while also participating in Admission, Review, and Dismissal meetings to support student needs; and,
