**WHEREAS**, Mrs. Favela Barceleau is married to Retired LTC Jaime Barceleau, LSW, and stepmother to two daughters, Clarissa and Ashley Barceleau. She is the surviving mother of Army SPC Robert Andrew Phoenix, who passed away at the untimely age of 25; and,
