**RENEWAL AGREEMENT**

This Renewal Agreement (this “**Agreement**”) is entered into effective as of the 29th day of July 2024 (the “**Effective Date**”), by and between the County of El Paso, Texas (the “**County**”) and Soto Enterprises, Inc., d/b/a Miracle Delivery Armored Service (“**MDAS**”). The County and MDAS may be referred to as a “party” or the “parties.”

**RECITALS**

**WHEREAS**, the parties entered into a Service Agreement (Contract No. 2020-1121) and a First Amendment to Service Agreement (Contract No. 2024-0043) (collectively, the “**Service Agreement**”); and

**WHEREAS**, the term of the Service Agreement is set to expire on July 31, 2024, and the parties desire to exercise the second and final renewal option.

**NOW, THEREFORE**, the parties agree as follows.

**AGREEMENTS**

1. **Term.** The parties agree to exercise the second of two options to renew the term of the Service Agreement. This renewal period shall commence on August 1, 2024, and expire July 31, 2025.

2. All other terms and conditions of the Service Agreement remain the same. If there is a conflict between the Service Agreement and this Agreement, this Agreement shall control.
