RESOLUTION



**WHEREAS**, Cinta De Oro, formerly known as Wrestler Sin Cara, was born and raised in Segundo Barrio, El Paso, Texas. Cinta De Oro is one of the few El Pasoans to receive a contract with World Wrestling Entertainment (WWE), which happens to be one of the largest entertainment companies in the world; and,

**WHEREAS**, Cinta De Oro's dedication to excellence was evident even throughout his high school years. He achieved the remarkable feat of becoming the 1996 Texas State Wrestling Champion with a record of 35-0 in his senior year at Burges High School and was voted the most outstanding wrestler in the State of Texas.

**WHEREAS**, Cinta De Oro is a four-time world champion, and has held titles such as World Champion World Wrestling Association (WWA), three-time International Open Challenge World Champion, two-time Florida Championship Wrestling Tag Team Champion, and one-time NXT World Tag Team Champion. He was recognized as El Paso's first Wrestling and Lucha Libre Hall of Fame Inductee in 2023. Cinta De Oro also received the Icon Award in 2023 and El Paso Wrestling Hall of Fame Inductee in 2017.

**WHEREAS**, Cinta De Oro's inspirational journey, as depicted in his memoir "El Verdadero Campeonato," serves as a beacon of hope and perseverance for individuals facing adversity; and,

**WHEREAS**, His profound impact on the borderland has demonstrated an unwavering commitment to the Sun City, its people, and future generations, recognizing him as a true champion both in and out of the ring.

**NOW, THEREFORE, BE IT RESOLVED**, that the El Paso County Judge and Commissioners Court do hereby recognize August 12<sup>th</sup> as "Cinta De Oro Day" in recognition of his outstanding achievements in sports entertainment and his exceptional career as a luchador.
