Background:	<p>The County has received notification of funding award in the amount of \$7,738.00 for mortgage assistance to supplement a recent award of \$44,260 for mortgage assistance. The \$7,738.00 Emergency Food and Shelter Program (EFSP) State Set-Aside will add to the existing mortgage assistance efforts in the general assistance program bringing the total award to \$51,998. Approximately 88 households may be assisted with mortgage assistance through these funds. Spending period is retroactive to 10/01/2022 through 12/31/2024.</p> <p>The LRO Certification e-sign form reflects the County agrees to the terms and conditions for receiving written notices and disclosures regarding the grant funds via DocuSign.</p>


