**ADDENDUM 1
TO TERMS AND CONDITIONS OF SALE**

The terms and conditions of this Addendum and of the Terms and Conditions of Sale may only be modified in writing and must be signed by Vendor and County.

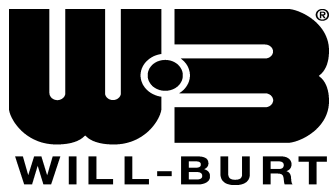

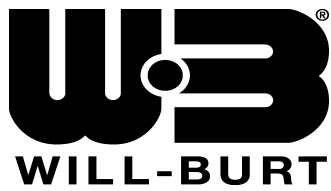

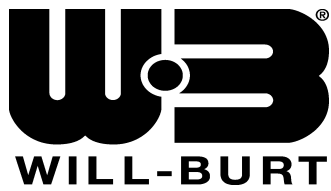
