Subject:	Discuss and take appropriate action to adopt the 2024 Property Tax Rate for the El Paso County Hospital District d/b/a University Medical Center of El Paso.
Background:	In accordance with the Texas Health and Safety Code section 281.096, it is requested that the El Paso County Commissioners Court adopt a tax rate for the El Paso County Hospital District for the 2024 tax year in the amount of \$0.219526 per \$100 assessed valuation, consisting of \$0.185607 per \$100 assessed valuation for maintenance and operations and a rate of \$0.033919 per \$100 assessed valuation for payment of the principal and interest on the debt of the Hospital District. The Hospital District Board of Managers previously approved the requested tax rate on August 7, 2024.

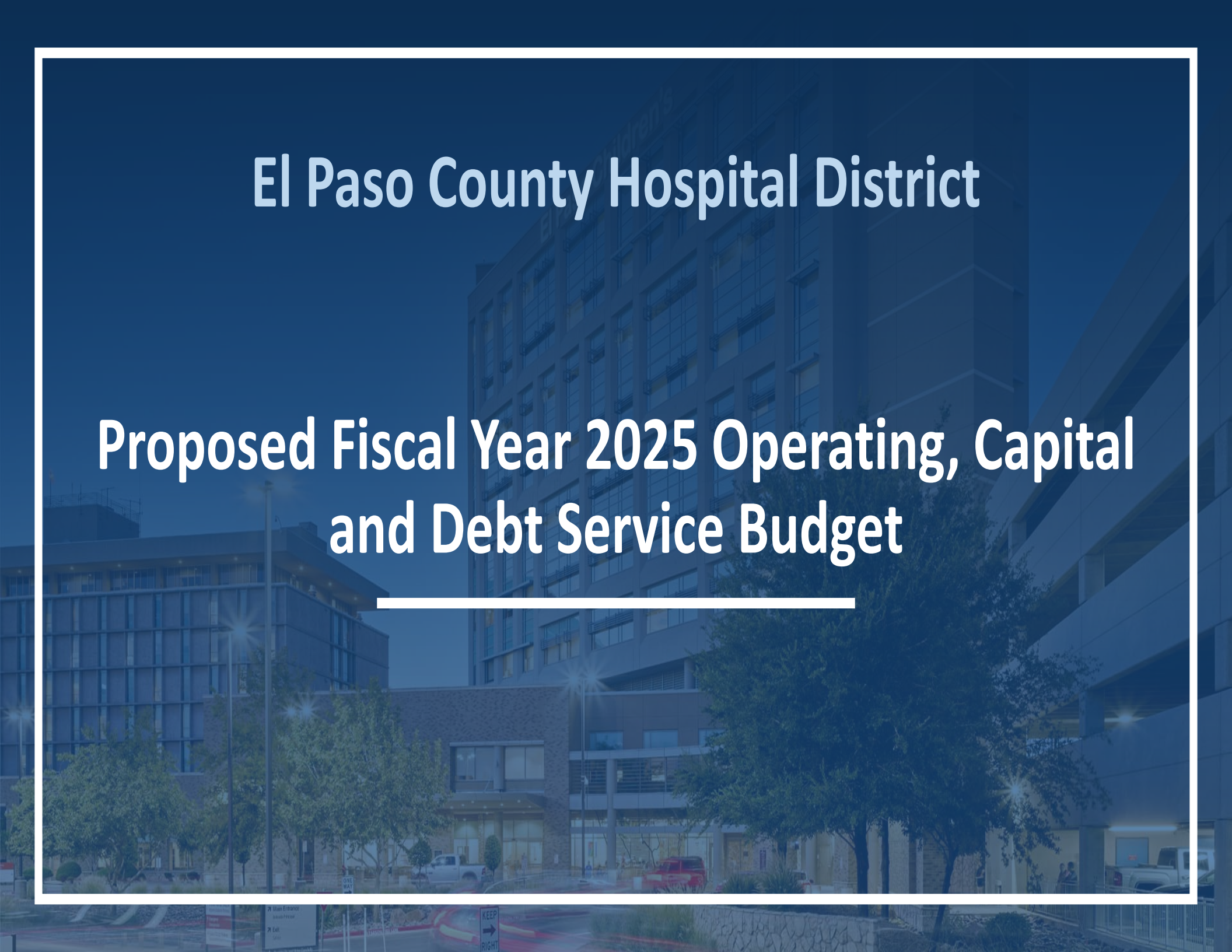

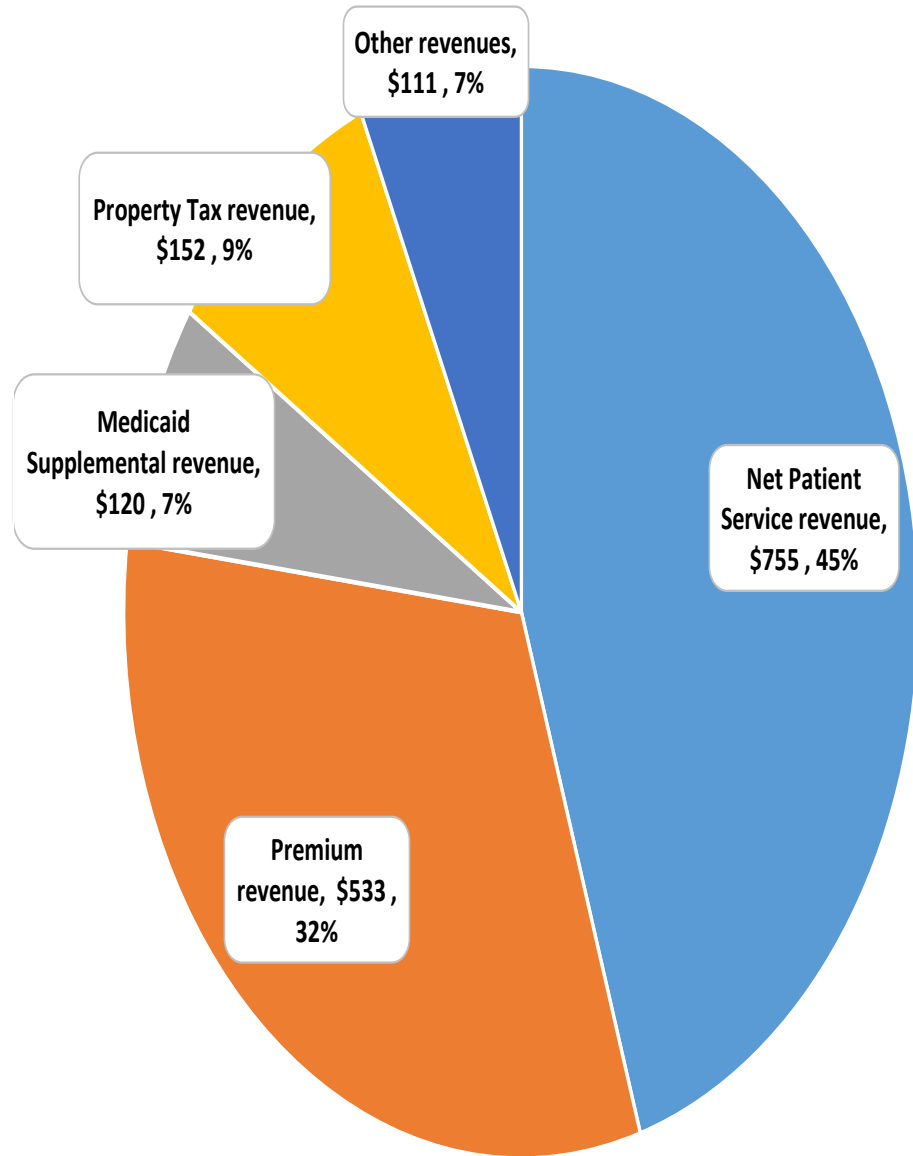

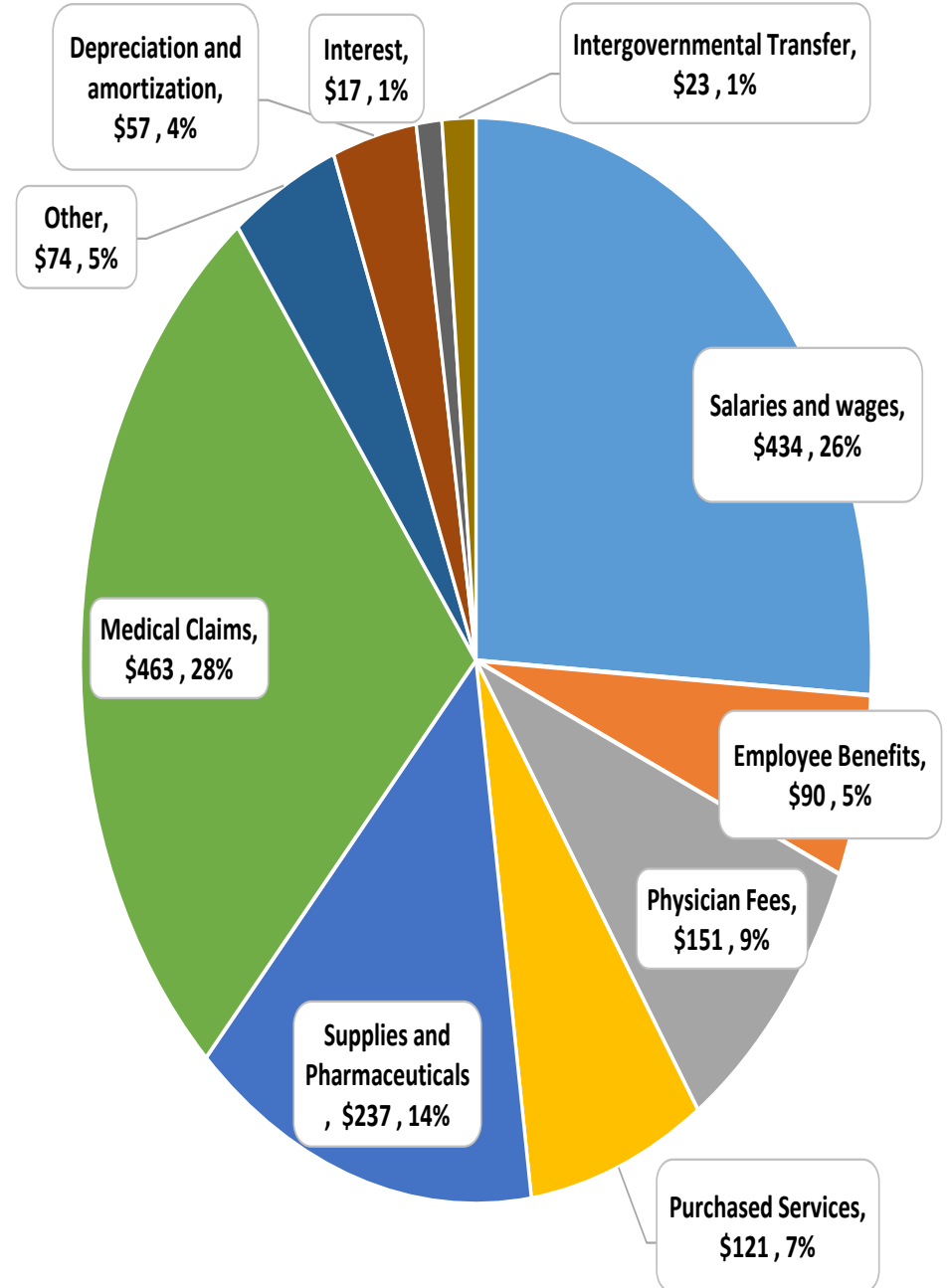
FY 2025 Proposed Operating Budget Revenue and Expense Assumptions

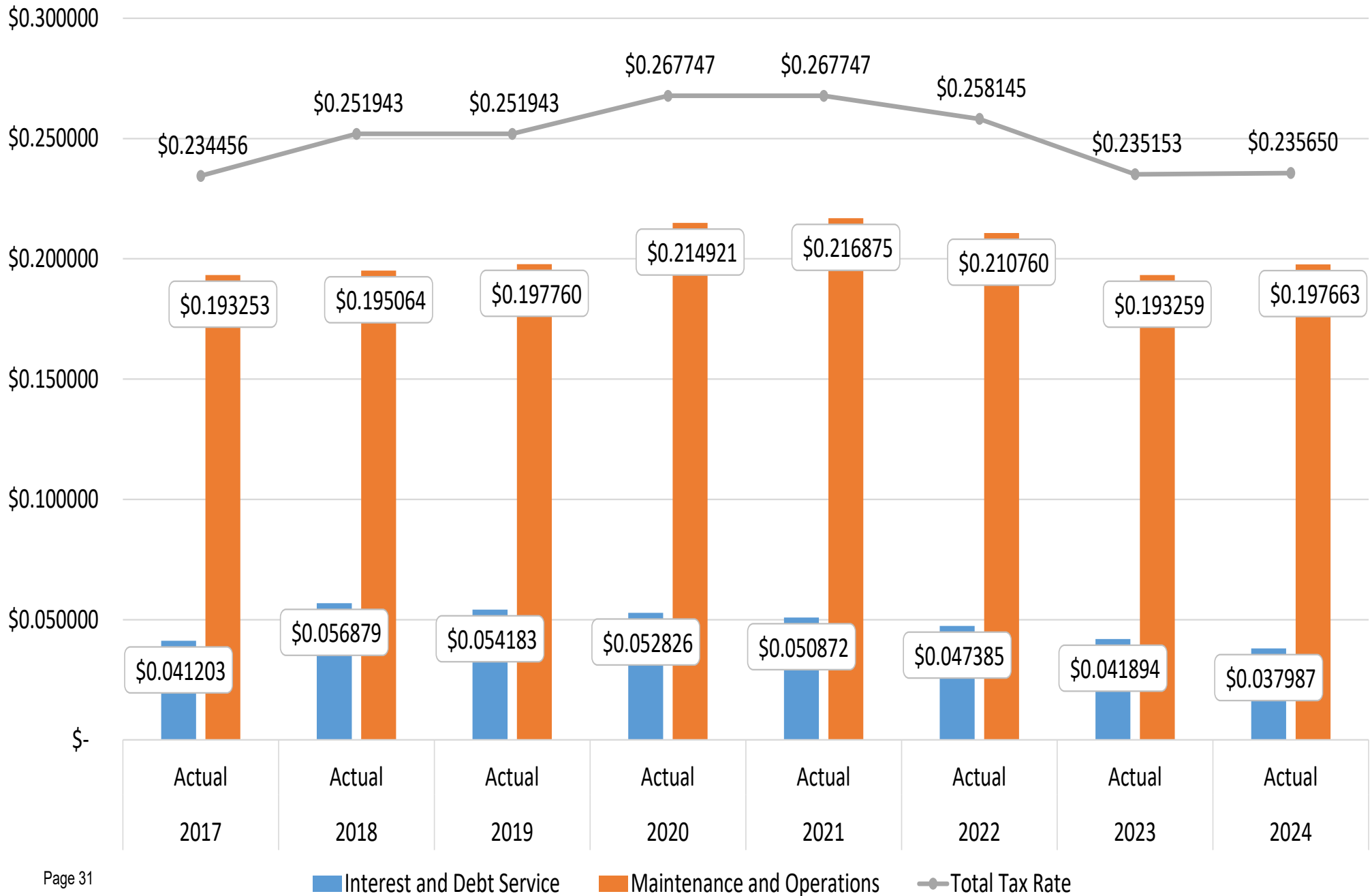

Community Tax Rate, El Paso ISD



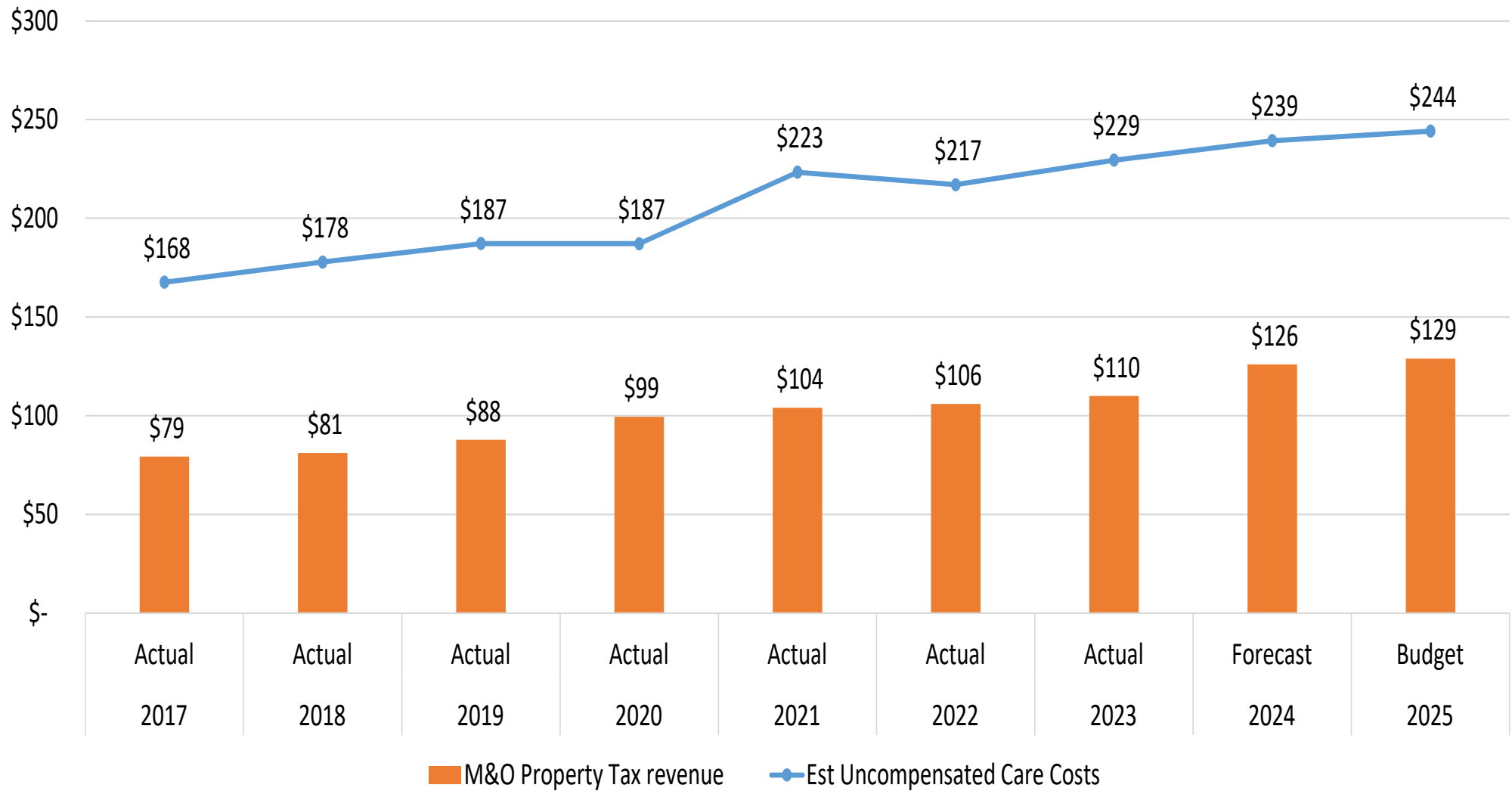
