| Background: | The goal of the Family Drug Court is to provide participants with substance abuse treatment, structure, accountability, and the necessary parenting skills to become a drug-free nurturing parent. The funds will purchase drug testing supplies, therapy workbooks, Strengthening Families Program (parenting classes), Substance Abuse Outpatient Treatment, Sun Metro bus passes, training for staff, and supplies. |
