Funding is available in GF-GADM-XFER OUT-GRANT MATCH.
Background:	<p>El Paso County currently has programs funded by the Office of the Governor with grant end dates of 9/30/2024 that have not received continuing awards. Each year, these grantor agencies are typically a month or two late to award continuing funding prior to the new grant period.</p> <p>This agenda item is asking for temporary coverage of expenses, until grant awards are effective and full reimbursements are made. Please note, expenses will ONLY be reimbursed if the grant awards are provided and accepted. Should a grant not be awarded or accepted for any of the nine programs, the County must absorb the costs incurred (both personnel and contractual) from October 1, 2024 through November 30, 2024. If an award has not been received by late November, this will be brought back to Commissioners Court for further discussion.</p> <p>This is an annual procedure to fund costs in between grant award years. GF is reimbursed once the grant is fully executed for the upcoming year.</p> <p>A full list of the programs and dollar amounts needed as part of this request are available in the Fiscal Impact section.</p>
