Background: The County of El Paso was seeking Request for Proposals (RFP) to solicit proposals from qualified vendors ("Vendor", "Vendors", "Offeror" or "Offerors") for Third Party Group Medical and Dental Plan Administration, Pharmacy Benefit Management, Stop Loss Reinsurance / Employee Assistance Program, Section 125 Plan Administration (Flexible Spending Accounts, Dependent Care Accounts) and Health Savings Account Administration, COBRA Administration for the El Paso County, Texas (the "County" or "Issuer").

Contract Term: Four (4) years, and the County has the option to extend the agreement for two additional one-year terms. The County will also consider a 6- or 10-year

agreement with the ability to add subcontractors through the awarded vendor to administer related programs.

Proposals were received and evaluated by a committee consisting of representatives from the County Human Resources Department. The Purchasing Department facilitated the evaluation process. Evaluation criteria included:

The evaluation team reviewed, scored, and ranked the firms against the evaluation criteria Aetna Life Insurance Company of Hartford CT, for Dental Services, Health Care Service Corporation A Mutual Legal Reserve Company dba Blue Cross Blue Shield of Texas of Richardson TX, for COBRA, EAP, Health, Pharmacy, Section 125, and Stop Loss Services, and United HealthCare Services Inc. of Minnetonka MN for Medicare Advantage Services was determined to be the most qualified firms to meet the County's needs.

Hi Araceli,

I agree with the below recap. To further summarize the consensus, the evaluation team decided to recommend the Dental to Aetna due to the lower administrative fee and lower claims cost expense. For the Medicare Advantage Plan, the evaluation team agreed that while United did not identify rates during the kickoff round, their BAFO was a fraction of the cost for the same service that is being provided by the current incumbent. Under the COBRA, EAP, Health, Pharmacy, Section 125- HSA/FSA, Stop Loss, the evaluation team agreed Blue Cross Blue Shield offered a better rate package with a decrease in overall claims cost and higher pharmacy rebates.

RE: Legal Determination Concerning Use of Closed Session under Section 551.0725

Section 551.0725 of the Texas Government Code (Open Meetings Act) authorizes a commissioners court to conduct a closed meeting to deliberate business and financial issues relating to a contract under negotiations, if the following conditions are met:

1. Commissioners Court votes unanimously that deliberation in an open meeting would have a detrimental effect on the position of the commissioners court in negotiations with a third party;
2. The attorney advising the commissioners court issues a written determination that deliberation in an open meeting would have a detrimental effect on the position of the commissioners court in negotiations with a third party; and
3. A tape recording of the proceedings in closed session is made.

This memorandum serves to fulfill the requirement described in number 2.

The Commissioners Court is currently in negotiations to award a contract for Third Party Administration for Health, Dental, and related benefits for El Paso County. The information to be discussed includes issues involving business and financial information related to those active contract negotiations. This information will include recommendations as to what the County's negotiation position should be, and the Commissioners Court must be free to analyze the business and financial concerns critically without undermining the County's position. Discussing this business and financial information and the County's negotiation position will naturally require a discussion of the different offers and the range of authority in responding to those offers in the attempt to negotiate a final agreement.

As your legal advisor, I have determined that deliberation in an open meeting concerning business and financial issues relating to those negotiations would have a detrimental effect on the position of the Commissioners Court in negotiations. Thus, I am requesting that Commissioners Court unanimously vote that deliberations in an open meeting would have a detrimental effect on the position of the Commissioners County in the negotiations, and that all said deliberations take place in closed session. I would further request that Commissioners Court direct the County Clerk to ensure that all proceedings in closed session be recorded.
